RESOLUTION NO. 01-11-21-02

A RESOLUTION OF THE BOARD OF THE SOUTH MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY AMENDING THE SOUTH MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY SANITARY SEWERAGE SYSTEM RATES, RULES AND REGULATIONS WITH RESPECT TO CERTAIN SEWERAGE RENTALS AND CHARGES.

BE IT HEREBY RESOLVED by the South Middleton Township Municipal Authority (the "Authority") as follows:

WHEREAS, the Authority has adopted certain sanitary sewerage service rates, rules and regulations with respect to the operation and use of the Authority's sanitary sewerage system facilities; and

WHEREAS, SMTMA's sewer rate schedule is Appendix A to said Rates, Rules, and Regulations; and

WHEREAS, the Authority, based on various budgetary considerations, believes that changes in certain sewerage rental charges and user rates are necessary and appropriate for use of the sanitary sewerage facilities of the Authority effective beginning upon the first quarter billing issued in 2021; and

WHEREAS, the Authority rates and charges, as amended hereby, are determined by the Authority to be reasonable and uniform in accordance with the requirements of the Municipality Authorities Act, 53 Pa.C.S.A. § 5601, *et seq.*, as amended.

NOW THEREFORE, it is hereby RESOLVED by the Authority as follows:

1. The recitals referenced above are incorporated herein by reference hereto.

2. Appendix A, Item 14 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a flat rate of \$135.00 per quarter for each private dwelling or living unit as made reference to in Section V.A.1.a.

3. Appendix A, Item 15 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a rate of \$145.00 as the minimum quarterly rate for commercial, minor industrial, public and school establishments as made reference to in Section V.A.2.

4. Appendix A, Item 16 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a fee of \$13.00 for each additional 1,000 gallons utilized in excess of the 15,000 gallons per quarter, as made reference to in Section V.A.2.

5. Appendix A, Item 17 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a fee of \$36.50 per quarter times the daily average number of employees for the quarter immediately preceding the quarter being billed, as applicable to Major Industrial Establishments and made reference to in Section V.A.3.

6. Appendix A to the Sanitary Sewerage System Rates, Rules, and Regulations as hereby amended is hereto as Exhibit "A" and is incorporated herein by reference.

7. Except as specifically amended herein, the Sanitary Sewerage System Rates, Rules and Regulations as previous adopted and subsequently amended shall remain in full force and effect.

8. The changes in the rates as noted in this Resolution shall become effective and be applicable to first quarter reading and/or assessment for 2021 and thereafter, unless changed by further resolution of the Authority.

9. The provisions of this Resolution shall be severable. If any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the remaining provisions of this Resolution or the Sanitary Sewerage System Rates, Rules and Regulations of the Authority.

10. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
