RESOLUTION NO. 01-11-21-01

A RESOLUTION OF THE BOARD OF THE SOUTH MIDDLETON
TOWNSHIP MUNICIPAL AUTHORITY AMENDING THE SOUTH
MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY WATER SYSTEM RATES, RULES
AND REGULATIONS WITH RESPECT TO CERTAIN WATER RENTALS AND
CHARGES.

BE IT HEREBY RESOLVED by the South Middleton Township Municipal Authority
(the "Authority") as follows:

WHEREAS, the Authority has adopted certain water service rates, rules and regulations
with respect to the operation and use of the Authority's water system facilities; and

WHEREAS, SMTMA's water rate schedule is Appendix A to said Rates, Rules, and
Regulations; and

WHEREAS, the Authority, based on various budgetary considerations, believes that
changes in certain water rental charges and user rates are necessary and appropriate for use of the
water facilities of the Authority effective beginning upon the first quarter billing issued in 2021;
and

WHEREAS, the Authority rates and charges, as amended hereby, are determined by the
Authority to be reasonable and uniform in accordance with the requirements of the Municipality
Authorities Act, 53 Pa.C.S.A. § 5601, *et seq.*, as amended.

NOW THEREFORE, it is hereby RESOLVED by the Authority as follows:

1. The recitals referenced above are incorporated herein by reference hereto.

2. Appendix A, Item 15 of the Water System Rates, Rules and Regulations is hereby amended to establish the following rates per quarter for each private dwelling or living unit, as made reference to in Section VII:

FIRST	6,000 GALLONS	\$ 38.00 MINIMUM
NEXT	244,000 GALLONS	\$ 3.10 PMG
OVER	250,000 GALLONS	\$ 1.50 PMG

3. Appendix A, Item 16 of the Water System Rates, Rules and Regulations is hereby amended to establish the following rates per quarter for commercial and public establishments, as made reference to in Section VII:

FIRST	12,000 GALLONS	\$ 64.00 MINIMUM
NEXT	88,000 GALLONS	\$ 3.10 PMG
OVER	100,000 GALLONS	\$ 1.50 PMG

4. Appendix A, Item 17 of the Water System Rates, Rules and Regulations is hereby amended to establish the following rates per quarter for industrial establishments, as made reference to in Section VII:

ALL CONSUMPTION	\$ 2.45 PMG

5. Appendix A, Item 21 of the Water System Rates, Rules and Regulations is hereby unchanged and maintains a fee of \$5.00 per 1,000 gallons for bulk water intended for potable use, which is transported by vendees' tank trucks.

6. Appendix A to the Water System Rates, Rules, and Regulations as hereby amended is hereto as Exhibit "A" and is incorporated herein by reference.

7. Except as specifically amended herein, the Water System Rates, Rules and Regulations as previous adopted and subsequently amended shall remain in full force and effect.


8. The changes in the rates as noted in this Resolution shall become effective and be applicable to first quarter reading and/or assessment for 2021 and thereafter, unless changed by further resolution of the Authority.

9. The provisions of this Resolution shall be severable. If any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the remaining provisions of this Resolution or the Water System Rates, Rules and Regulations of the Authority.

10. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
