## SOUTH MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY RESOLUTION NO. 12-11-2023-02

A RESOLUTION OF THE BOARD OF THE SOUTH MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY AMENDING THE SOUTH MIDDLETON TOWNSHIP MUNICIPAL AUTHORITY SANITARY SEWERAGE SYSTEM RATES, RULES AND REGULATIONS WITH RESPECT TO CERTAIN SEWERAGE RENTALS AND CHARGES.

BE IT HEREBY RESOLVED by the South Middleton Township Municipal Authority (the "Authority") as follows:

WHEREAS, the Authority has adopted certain sanitary sewerage service rates, rules and regulations with respect to the operation and use of the Authority's sanitary sewerage system facilities; and

WHEREAS, the Authority, based on various budgetary considerations, believes that changes in certain sewerage rental charges and user rates are appropriate for use of the sanitary sewerage facilities of the Authority effective for the first quarter billing issued in 2024.

NOW THEREFORE, it is hereby RESOLVED by the Authority as follows:

- 1. Appendix A, Item 10 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a flat rate of \$149.00 per quarter for each private dwelling or living unit as made reference to in Section V.A.1.a.
- 2. Appendix A, Item 11 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a rate of \$160.00 as the minimum quarterly rate for commercial, minor industrial, public and school establishments as made reference to in Section V.A.2.
- 3. Appendix A, Item 12 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a fee of \$14.70 for each additional 1,000 gallons utilized in excess of the 15,000 gallons per quarter, as made reference to in Section V.A.2.

4. Appendix A, Item 13 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a fee of \$40.00 per quarter times the daily average number of employees for the quarter immediately preceding the quarter being billed, as applicable to Major Industrial Establishments and made reference to in Section V.A.3.

5. Appendix A, Item 1 of the Sanitary Sewerage System Rates, Rules and Regulations is hereby amended to establish a fee of \$50.00 for the cost of a permit for sewer service.

6. Except as specifically amended herein, the Sanitary Sewerage System Rates, Rules and Regulations as previous adopted and subsequently amended shall remain in full force and effect.

7. The changes in the rates as noted in this Resolution shall become effective and be applicable to first quarter reading and/or assessment for 2024 and thereafter, unless changed by further resolution of the Authority.

8. The provisions of this Resolution shall be severable. If any of its provisions shall be held to be unconstitutional, illegal or otherwise invalid, that decision shall not affect the remaining provisions of this Resolution or the Sanitary Sewerage System Rates, Rules and Regulations of the Authority.
